ECCO FEI World Championships Herning – Denmark 2022 are open to all National Federations (NFs) who are members of the Fédération Equestre Internationale (FEI). If a National Federation does not declare their participation within the set entry period, then they may only do so with permission from the FEI and the Organising Committee (OC).

All people travelling to the ECCO FEI World Championships Herning – Denmark 2022 from countries without visa agreements with Denmark must obtain visas. The OC asks that all visa applications be made to the Danish Consulate/Embassy of their country as early as possible. ## 4.1 Summary of Stages

There are several stages to the entry process which are detailed below. In summary they are as follows:

## 4.2 Nominated Entries

Detailed entries with all complete information are required (names of Athletes and Horses). According to FEI General Regulations Art. 116.4, the list of Nominated Entries may consist of a higher number of Athletes and Horses than the Definite Entries. The maximum permitted numbers for Nominated Entries per NF per discipline are detailed below.

### **CH-M-D/Dressage**

**July 4<sup>th</sup> 2022**

Each NF may enter a maximum of 8 Athletes and 8 Horses.

### **CH-M-P/Para Dressage**

**July 4<sup>th</sup> 2022**

Each NF may enter a maximum of 8 Athletes and 8 Horses.

### **CH-M-S/Jumping**

**July 4<sup>th</sup> 2022**

Each NF may enter a maximum of 10 Athletes and 20 Horses.\*\*\*

### **CH-M-V/Vaulting**

**July 4<sup>th</sup> 2022**

Each NF may enter a maximum of 2 squads of 8 Vaulters (including 2 reserve Vaulters) with 2 Horses and 2 Lungers per squad; 8 individual female Vaulters with 8 Horses and 8 Lungers; 8 individual male Vaulters, with 8 Horses and 8 Lungers; and 6 Pas-de-deux (2 Vaulters per PDD including 2 reserve PDD of 2 Vaulters) with 6 Horses and 6 Lungers.

\*\*\* The fifth rider of the Athletes participating in CH-M-S/Jumping will be invited to CSI3\* competitions. See schedule for the Non-Championship competitions. Conditions to be confirmed therein.



### 4.3 Certificate of Capability

For Jumping and Dressage the Certificates of Capability must be entered in the FEI System by July 4<sup>th</sup> 2022. For Para Dressage and Vaulting the Certificates of Capabilities must be entered in the Hippobase System. The FEI confirms a certificate of capability for every Athlete and Horses (see 4.6 below).

### 4.4 Definite Athlete Numbers

To assist in planning (including confirming stabling numbers for venue development purposes), the OC is asking NFs to confirm on July 4<sup>th</sup> the definite number of Athletes and Horses (including reserves where appropriate) they intend to submit at Definite Entries stage per discipline (for maximum number see Definite Entries section 4.5). Entry fees are to be paid no later than this date (July 4<sup>th</sup>) based on the Definite Athlete Numbers.

### 4.5 Definite Entries

The names of the Athletes and Horses being definitely entered must be indicated and selected from those Athletes and Horses on the Nominated entry list.

The number of Horses indicated below (unless otherwise stated) represents the maximum number that the OC will provide stabling for on competition venue. Reserve Horses will not be accommodated on competition venue, unless stated as below. For NFs requiring stabling off competition venue please contact Malou Trabjerg on [mt@herning2022.com](mailto:mt@herning2022.com).



**CH-M-D/Dressage**

**July 25<sup>th</sup> 2022**

Each NF may enter a maximum of 4 Athletes and 4 Horses

**CH-M-P/Para Dressage**

**July 25<sup>th</sup> 2022**

Each NF may enter a maximum of 4 Athletes and 4 Horses.

**CH-M-S/Jumping**

**July 25<sup>th</sup> 2022**

Each NF may enter a maximum of 5 Athletes and 5 Horses.

**CH-M-V/Vaulting**

**July 25<sup>th</sup> 2022**

**Squad:** Each NF may enter 1 squad of 6 Vaulters, 1 Lunger and 1 Horse  
 2 reserve Vaulters

**Individual Female:** Each NF may enter a maximum of 3 individual Vaulters, 3 Lungers and 3 Horses.  
 1 reserve Vaulter

**Individual Male:** Each NF may enter a maximum of 3 individual Vaulters, 3 Lungers and 3 Horses.  
 1 reserve Vaulter

**Pas-de-Deux:** Each NF may enter a maximum of 2 Pas-de-Deux, with 2 Vaulters, 1 Lunger and 1 Horse per Pas-de-Deux.  
 1 reserve Pas-De-Deux (two Vaulters)

NB: Maximum 2 reserve Lungers and Horses per NF in total in Vaulting.

**Additional Horses not officially entered for the ECCO FEI World Championships Herning – Denmark 2022 will not be allowed on to the competition venue.**



## 4.6 Process for submitting entries and certificates of capability

### Jumping and Dressage

All entries must be submitted via the **FEI Entry System**. The OC and FEI will view the data supplied online as the only official entry information (including Certificates of Capability). Any information received by any other means, which is able to be entered directly into the FEI Entry System, will not be accepted.

### Para Dressage and Vaulting

All entries must be submitted via the **Hippobase System**. The OC and FEI will view the data supplied online as the only official entry information (including Certificates of Capability). Any information received by any other means, which is able to be entered directly into the **Hippobase System**, will not be accepted.

### Nominated Entries and Certificates of Capability

NFs should log into the FEI Entry System (for Jumping and Dressage) or the Hippobase System (for Para Dressage and Vaulting) and add Athlete and Horse details according to the maximum numbers per discipline detailed above (4.2).

NFs should generate the Certificates of Capability via the FEI Entry System or Hippodata System (see 4.3 above). Athletes and Horses not listed on this document will not be permitted in the Definite Entries, or be used for any substitutions. NFs should print, sign (NF President) and stamp the Certificate of Capability for each discipline and then scan and email each document to the respective FEI discipline departments.

Entries not submitted in accordance with the process summarised above and as detailed through the FEI Entry System (for Jumping and Dressage) or the Hippobase System (for Para Dressage and Vaulting) will not be accepted.

## 5. SUBSTITUTION

According to General Regulations article 116.2.2, nominated entries must include a list of the names of Athletes and Horses from which the Definite Entries **and any substitutions** will be chosen and state the number of Athletes and Horses which the NF intends to send.

FEI General Regulation article 121.3:

“In case of accident or illness of a team member and/or Horse nominated for a team Competition, such individual Athlete and/or Horse entered in that Event may be substituted. This must be announced by the Chef d'Equipe at the latest one hour before the start of the relevant Competition unless otherwise specified in the relevant Sports Rules. The Athlete/Horse being withdrawn cannot then take part in any other Competition in that Event.”

All substitutions must come from the NF's list of Nominated Entries and submitted in accordance with FEI General Regulation article 121.3 (above) and as specified in the relevant discipline regulations:

## 7. RULES FOR PARTICIPATION

### 7.1 General Conditions

Rules for Participation: For further information, see under respective discipline.

As soon as NFs have presented their entries, all Chefs de Mission, Chefs d'Equipe, Athletes, also on behalf of the Horse owners, as well as their employees/grooms, representatives and accompaniments are requested, upon arrival at the venue, to acknowledge and keep within the FEI Code of Conduct and all applicable FEI rules and regulations, including but not limited to the FEI Equine Anti-Doping and Controlled Medication Regulations and FEI Anti-Doping Rules for Human Athletes, as well as to behave according to ethical principles in common practice. Violations will be dealt with by the appropriate person or body, such as Ground Jury or FEI Tribunal depending on the nature of the violations. All Athletes and Chefs d'Equipe must sign the Code of Conduct and Athlete Waivers. Chefs d'Equipe are required to submit the signed copies of the FEI Code of Conduct for Welfare of the Horses and Athlete Waivers to the National Federations Desk upon arrival. (See [Appendix 1](#) and [2](#)).

In accordance with FEI General Regulations article 135.1 the OC reserves the right to use Athlete/Horse images produced during the Games for promotional purposes.





## 7.2 FEI Code of Conduct for Welfare of the Horse

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the Horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition Horses, welfare must take precedence over all other demands. This includes good Horse management, training methods, farriery and tack, and transportation.
2. Horse and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and misuse of aids.
3. Events must not prejudice Horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the Horse for onward travel after the event.
4. Every effort must be made to ensure that Horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their area of expertise.

## 9. LIABILITY & INSURANCE

The OC declines any liability for property or pecuniary damage which may happen to visitors, Athletes, grooms and Horse owners through slight negligence of the OC, its delegates or its assistants. The OC also declines any liability for theft, fire or other incidents.

By making the Definite Entries, each Athlete declares that he/she has taken notice of the schedule and exclusion of the liability as set out in the schedule and that the Athlete explicitly agrees therewith. All Athletes are required to sign the waiver and Chefs d'Equipe are required to submit the form to the National Federations Desk upon arrival. (See Appendix 2)

### Insurance

#### Third-party insurance

All Chefs de Mission, Chefs d'Equipe, Athletes, owners, trainers, team veterinarians (see FEI Veterinary Regulations 2020) and their accompaniments are personally responsible for damages to third persons caused by themselves, their employees/grooms, their agents or their Horses. They are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep this policy up to date. The OC/FEI will NOT be responsible for any damage caused by Athletes, their Horses, NF officials, their employees/grooms or their representatives.

## 10. MEDICAL & ATHLETE ANTI-DOPING

Medical services will be available on the Venue from August 2<sup>nd</sup> – 14<sup>th</sup> 2022. Medical services provided at the Venue are free of charge. For further information and medical services at the Athlete/NF's expense, please see "Medical Service Guide".

In order to provide the best possible care, a medical form will need to be completed by all Athletes and will be kept confidential by our Medical Services (See appendix 5).

More detailed information about the medical care, can be found under the "Medical Service Guide".

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. The FEI Anti-Doping Rules for Human Athletes (ADRHA) are published on the FEI's website at <https://inside.fei.org/content/anti-doping-rules>.

### **11.3 Veterinary Examinations, Horse Inspections, and Passport Controls**

Veterinary Examinations, Horse Inspections, and Passport Controls will be carried out in accordance with FEI Veterinary Regulations and the discipline-specific veterinary regulations. On arrival at a the venue all horses must undergo an examination by a veterinarian to confirm their identification from their passport, their vaccination status and general health. To protect all Horses attending events, any Horse with a questionable health status, with regards to vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses deemed not fit to compete will be eliminated by the Ground Jury and not be permitted to continue in the competition.

### *Influenza*

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the FEI Veterinary Regulations (Article 1028) and as summarized below.

### ***Other Recommended Immunizations***

The Veterinary Service Team of Herning2022 recommends that all NFs, even if not compulsory under FEI Rules and Regulations, give serious consideration and implement vaccination strategies to ensure their Horses have established immunity against Equine Herpes Virus Type I.

Any vaccinations should be recorded on the Horse's individual passport or accompanying health certificate.

## **11.4 Equine Anti-Doping and Controlled Medication Testing**

See FEI Veterinary Regulations 14<sup>th</sup> edition, 1<sup>st</sup> January 2022 Chapter VII.

All horses competing at FEI Events may be subject to sampling for the presence of Prohibited Substances in accordance with FEI Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. The FEI Equine Anti-Doping and Controlled Medication Regulations are published on the FEI's website at <https://inside.fei.org/content/anti-doping-rules>.

## 11.5 Team Veterinarians

Upon arrival at the venue, all official Team Veterinarians must announce their presence at the office in the veterinary area and provide the Veterinary Centre with a completed PTV Event Registration Form. All veterinarians must conduct themselves during the Championships in compliance with the current FEI Veterinary Regulations and other FEI relevant Rules and Regulations. All Veterinarians requiring stables accreditation must be in possession of an FEI Permitted Treating Veterinarian card. Accreditation for veterinarians will be withdrawn for failure to register in this way.

Veterinarians who are established and lawfully conduct veterinary activities outside Denmark may practice in Denmark, on the occasion of the ECCO FEI World Championships Herning 2022 - Denmark only, without being obliged to apply for registration. However, a prior declaration to the regional veterinarian authorities. A form will be sent to NFs by the OC in due course.

Interested parties are required to comply with professional standards applicable in Denmark and are subject to the disciplinary jurisdiction of the College of Veterinarians.

### Conditions of Importation

At the time of the first veterinary examination, i.e. upon arrival of the Horses on the venue and before entering the stables, every Athlete is obliged to present a valid FEI passport or an FEI Recognition card cover on an approved passport as well as the health certificates which are required for the transport to the event. For further information, please see the “Transportation & Stable Service Guide”.

### Costs covered by the Organising Committee

**Non-European Origin Horses:** The OC is liable to cover the costs for all qualified Horses arriving and departing into/from Billund Airport during the arrival & departure windows as follows:

- All landing & handling charges at Billund Airport
- Trucking to and from Billund Airport only if going directly to and from the Championship Venue.
- All export & handling charges to and from Billund Airport.
- Ministry costs for return health certification

The above costs will only be covered by the OC if the arrangements are coordinated by and through the Designated Shipping Agent, Peden Bloodstock.





### Arrival & Departure Windows

The following are the arrival & departure windows in Billund Airport. During these windows the OC will cover all costs listed above for Non-EU Origin Horses:

- Dressage, Para-Dressage, Jumping, Vaulting: 2nd August – 15th August 2022

### **Costs covered by National Federations**

Each NF is responsible for the following costs related to the transport of their Horses, attendants & equipment to and from Denmark:

- **Horses**
  - All CIF (cost, insurance & freight) costs from the country of origin up to Billund airport
  - All charges imposed by Customs for Temporary or Permanent import
  - All costs from “FOB” (free on board) Billund airport to country of origin
  - All pre export quarantine charges in Denmark if required by the country of destination
  - All pre export blood testing related costs if required by the country of origin/destination
- **Horse Equipment**
  - All costs related to the shipment of equipment up to and/from the Championship Venue
  - All charges imposed by Customs for Temporary or Permanent import

### **Horses Lorries & Parking**

Restricted parking for horse - &/or equipment vehicles will be provided. Further details are available within the “Transportation and Stable Service Guide”.

## **13. FEED, HAY AND BEDDING**

The following will be made available to NFs:

- Commonly used feed will be available to buy



- Straw and shavings will be available to buy (in addition to the allowance included in the entry fee).

Further details (products and prices) will be available in the “Transportation and Stable Service Guide”. Purchased items will be charged on the NFs account, and invoices will be issued and must be paid before departure.

## 14. STORAGE OF EQUIPMENT

### Tack Stalls

The OC will provide tack stalls according to a ratio of at least one for every three Horses for all disciplines.

Extra tack stalls will not be available. If extra space for equipment is needed, it will be possible to rent storage containers.

NFs should be aware that horse lorries will be parked at the stable compound and that lorries can be used for storage of tack and equipment. Please note that lorries in which grooms stay will be parked immediately adjacent to the stables.

### Storage Containers on-site

Storage Containers can be rented for storage of equipment at the NF’s expense. Storage containers must be requested by the Nominated Entry Date (July 4<sup>th</sup> 2022). For further details and prices, please see “Transportation & Stable Guide”.

### Shipping Containers

Shipping containers are not provided by the OC. However, if NFs wish to bring their own shipping container for shipping and storage of equipment, NFs should contact Peden Bloodstock no later than July 4<sup>th</sup> 2022.



## 15. ACCREDITATION

Members of NF delegations will be granted access to the Venue under the conditions listed below. Accreditation permitting entry to stable area according to FEI Veterinary Regulation Art. 1009.

Applications by National Federations (NF) for all Accreditations must be made online by the relevant NF through the HippoBase Entry System.

The application for Accreditation Holders with accommodation paid by the OC (Chefs de Mission, Chefs d'Equipe, Team Veterinarian, Athletes, and Grooms) must be submitted no later than **July 4th 2022**.

All other applicants for Accreditation must be submitted as soon as possible and no later than **July 27th 2022**.

An "Accreditation& Catering Service Guide" will be available to NFs specifying

- the detailed Accreditation Rules
- details on allocations and rules per NF, per discipline, per athlete
- additional details to be entered for people with certain functions
- conditions for paid accreditations
- the collection process

If national/regional/local Covid-19 government restrictions limit the number of people present at the event the OC may limit the accreditation positions to those essential to run the competitions.

### 17.1 National Federation Accommodation provided at Organising Committee Cost

## 17.4 Accommodation for Grooms

Grooms will be accommodated on competition venue:

- An alternative accommodation solution will be provided for Grooms without access to lorries. They will be accommodated in Grooms Village in temporary shared structures, with a common shower/toilet area for all Grooms. This must be ordered by Nominated Entry.
- A special lorry parking area will be set up next to the stables, for the Grooms who chooses to stay in own lorries, instead of the Grooms Village. Parking for all other lorries will be located at an area beyond the Grooms lorries.

## 18. CATERING

## 19. TRANSPORTATION

### 19.1 Arrivals and Departures

Official points of arrival in Denmark for the NFs:

- Airport: Billund Airport
- Train station: Herning Station

OC will provide, if needed, a shuttle service from these points of arrival to the NFs' hotels or the Venue, for the Accreditation Holders at OC expense: Athletes, Grooms, Chefs de mission, Chefs d'Equipe, Team Veterinarians. This service will be available at **the dates where the OC will pay for the accommodation for the respective Accreditation Holder**.



## 19.2 Reimbursement of travelling and transportation expenses

The OC will pay a lump sum for the travelling and transportation expenses of the Horses, from the Danish border to the Venue.

The OC will pay:

- 60 Euros per definitely entered Horse for Dressage, Para Dressage, Vaulting and Jumping.
- The lump sum must be ordered prior to arrival no later than by Definite Entry date. Please contact Malou Trabjerg at [mt@herning2022.com](mailto:mt@herning2022.com) to order.

## 19.3 Transport Operations

### *Transport service between hotels and the Venue*

Accreditation Holders with shuttle paid by OC will have access to a transportation service between hotels and the Venue. Service will start **the dates where the OC will pay for the accommodation for the respective Accreditation Holder** and end one day after last day of respective competition, and will be adapted to the Stables opening/closing times. More information will be available in the "Accommodation & Shuttle Service Guide".

## 19.4 Transport for Para Dressage

Based on the size of its Para Dressage delegation, each NF will have their own assigned wheel chair accessible vehicle(s). Every NF who is in need of a wheel chair accessible vehicle(s), will need to inform [mt@herning2022.dk](mailto:mt@herning2022.dk) about the size of the Para Dressage delegation with these needs.

## 19.5 Parking passes

Each Chef de Mission will receive parking passes, for the amount of cars, for the existing parking area near the Venue, for the entire duration of the Championships.

Each Chef d'Equipe will receive one parking pass for the duration of the relevant discipline for a parking area near the venue.

Limited additional parking passes will be available for purchase by NFs according to availability. For prices and more details, please see the “Accommodation & Shuttle Service Guide”.

## **19.6 Motorised vehicles and bicycles on venues**

No motorised vehicles (golf cars, motorbikes, Segway’s etc) other than the OC’s own vehicles, except wheelchair accessible vehicles, will be allowed on the venue. Bicycles will be prohibited on the Venue, but will be permitted in the Grooms Village. Bikes are not allowed in the stable area. Wheelchairs and mobility scooters will be permitted on venue.

## **20. SETTLEMENT OF ACCOUNTS**

Payment of prize money, reimbursement of transport, traveling expenses and accommodation guarantee will be paid out by bank transfer from the OC only to the respective NFs. For this purpose the NFs are requested to state their bank information (name of recipient, bank name, bank code, account number, IBAN and BIC codes) in the form in Appendix 3 and to send it by July 4<sup>st</sup>, 2022 at [economy@herning2022.com](mailto:economy@herning2022.com). The NFs will receive receipts for the settlement of account by regular mail.

Upon settlement NFs will be provided with a detailed breakdown of account per Athlete/Team per discipline. The account will detail the amount of prize money paid per Athlete/Team, any tax deductions made at source, and a breakdown of transport/travel payments being made per Athlete/Team.

## **21. PROTESTS & APPEAL**

Protests and/or appeals must be made in accordance with the FEI General Regulations and to be valid must be accompanied with the corresponding deposit.

## **22. EVENT ORGANISATION (FEI General Regulations Art 109 and 110)**

In exceptional circumstances, together with the approval of the Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the OC may change the schedule in order to clarify any matters arising from an omission or due to unforeseen circumstances. Any such changes will be notified to all Athletes and Officials as soon as possible and reported to the FEI Secretary General by the President of the Ground Jury.

## **23. CANCELLATION OF THE EVENT**

In exceptional circumstances and with the approval of the FEI, the OC reserves the right to take all necessary actions including the cancellation of the event or part of the event and in this case will repay the respective entry fees to NFs. Also, with the new provisions in the GRs (art. 110.13), the FEI Secretary General can cancel the event in case of for example an EHV-1 outbreak.

## **24. ADVERTISING AND PUBLICITY ON ATHLETES AND HORSES**

The OC authorises the Athletes to wear clothing and use equipment (including, but not limited to, riding equipment and vaulting back pads) and vehicles which identify the manufacturer, the Athlete's sponsor(s), the Athlete's team sponsor(s), the NF's sponsor(s), the Athlete's nation, and/or the Athlete himself, only under specific conditions set forth by the Article 135 of the FEI General Regulations 24<sup>th</sup> edition, 1<sup>st</sup> January 2022.

The Chief Steward is responsible for ensuring that FEI Regulations relating to Art 135 are respected by Athletes before entering the arena. Athletes not complying with Art 135 will not be permitted to enter the arena during competition.

## **25. HORSES LEAVING THE OFFICIAL VENUE**

Horses may not leave the Venue during the period of the Event, unless exceptionally authorised by the Veterinary Commission/Veterinary Delegate.



## 26. STABLES SAFETY AND SECURITY

The following security regulations of the Fire Department will need to be obeyed:

- Smoking will be strictly prohibited in the stable area.
  - Open fires (e.g. camping stoves) will be strictly prohibited,
  - Only the required amount of feed supplies may be stored in the stables
  - No equipment, feed, bedding etc. may be stored on the stable aisle
  - Open space and entry ways between the stables may not be obstructed by equipment (except normal size trunks),
  - All electrical plugs will be Danish sockets (220V), participants will need to bring adaptors.
  - No one will be allowed to stay in the stables overnight due to the local fire ordinance.
- For procedures regarding monitoring of horses overnight (See appendix 4).

Those who disregard the above security regulations may incur a fine and/or other appropriate sanctions.

## 27. PETS

Dogs (except guide dogs) and all other pets will be strictly prohibited on the Venue (EquiPark, Stutteri Ask Stadium, Jyske Bank Boxen, BB Horse Arena included).

Dogs are allowed in the stable area and Grooms Village if **the dog is on a leash**. If this rule is not complied with, a fine of 500 EURO will be issued.

## 28. CHEF WORKING AREAS

The OC will provide a working area on the venue for all Chefs de Mission and Chefs d'Equipe. These areas will have internet access.

## 29. CEREMONIES, INTERVIEWS

### 29.1 Medal and Prize-Giving Ceremonies

All medallists will be obliged to take part in the official medal ceremonies. The ceremonies will include only medal winners with their winning Horses. For Para Dressage all individual medal winning horses and team gold medal horses will take part.

Each NF will be requested to provide the OC with their official national anthem (musical audio version exclusively, WAV or AIFF format if possible) and their official national flag (image format) by March 15<sup>th</sup> 2022. In the event of a change of national anthem or flag between March 15<sup>th</sup> 2022 and the Championships, NFs must inform the OC and supply the latest version.

## **29.2 Medal Celebrations**

Detailed information regarding Medal Celebrations will be communicated to NFs in due course.

## **29.3 Mixed Zone, Press Conferences and Interviews**

All Chefs de Mission, Chefs d'Equipe, Athletes, team personnel and especially medallists and placed athletes are expected to make themselves available for interviews when requested by the ECCO FEI World Championships Herning – Denmark 2022.

In addition, all Athletes and Team Trainers will be obliged to pass through the flash interview and mixed zones after competing.

All medallists, placed athletes and the best Danish athlete of the respective discipline are obliged to attend the Press Conference at the end of the day of competition. Other persons may be requested by media, and their presence would be greatly appreciated upon request of the ECCO FEI World Championships Herning – Denmark 2022 Media Team.

## **29.4 Kiss & Cry Areas**

Each stadium will have a “Kiss and Cry” area. A maximum of 10 Accreditation Holders are allowed in the Kiss and Cry area and it is the responsibility of the Chief d'Equipe of the competing Athlete to administer the 10 persons.

## **30. ACCREDITED SEATING AREA**

Accredited seating areas composed of a limited number of seats, that will be available at each competition arena for all NF accredited personnel on a first come first serve basis. All seats will be free of charge.

a) In the event of equality between teams for first place, there will be a jump-off against the clock in which all team Athletes may take part, at a speed of 400 meters per minute over six obstacles, which may be increased in height and/or spread.

b) Teams on equality of penalties for any other placing will be placed according to the combined times of their three best athletes in the second round of the second competition, the team with the faster time being placed ahead of the team with the slower time.

d) If after the jump-off there are teams with equality of penalties and time, the teams concerned will be placed equal.

### **Starting Order**

According to Art. 310.4 (Rules for Jumping Championships and Games, 27<sup>th</sup> Edition, 2022).

#### *First Round*

The starting order in the first round of the second Competition will be determined by a new draw in accordance with the same procedure as provided for the first Competition.

#### *Second Round*

The individuals among the 60 best placed Athletes (plus those tied for 60<sup>th</sup> place) following the first Competition and the first round of the second Competition will compete in the second round before the 10 best placed teams and those with equality of Penalties for the 10<sup>th</sup> place begin their second round. For the avoidance of doubt, team Athletes who are among the aforementioned 60 best placed Athletes, but whose team is not qualified for the second round, will compete as individuals in the second round (refer to Art. 310.3.2.3).

There must be an interval of at least 30 minutes between the second round for individuals and the second round for the teams.

The starting order for those qualified to participate as individuals in the second round is according to the reverse order of total Penalties incurred in the first Competition and the first round of the second Competition. In case of Athletes with equality of Penalties, the Score (time) of the first Competition will decide their starting order.

The starting order of the 10 best placed teams and those teams with equality of Penalties for 10<sup>th</sup> place in the second round is according to the reverse order of the total Penalties of the best three Athletes per team incurred in the first Competition and of the best three Athletes per team in the first round of the second Competition. In case of equality of total Penalties teams retain the same starting order as in the first round.

In addition to the Team classification there will be an individual classification with prizes for the Second Competition.

25% of the prize money for the overall classification in the Championship will be distributed in accordance with the prize money distribution table published above, to the Athletes placed 13th-25th in the overall individual placing in the Championship following Round A. If fewer than 25 Athletes take part in Round A, the prize money foreseen for Athletes placed 13th to 25th will be distributed among the Athletes placed 13th to last in the overall individual placing in the Championship following round A.

75% of the prize money for the overall classification in the Championship will be distributed to the Athletes placed 1st to 12th in the overall individual placing in the Championship following Round B. If fewer than 12 Athletes take part in Round B, the prize money foreseen for the first 12 placings will be redistributed among those who do take part.

#### **Athletes/Horses**

- Round A of this third Competition is compulsory for the 25 best placed Athletes and Horses (including those placed equal for 25th place) according to the cumulative penalties over the first and second Competitions.
- Athletes must have taken part in the first Competition (completed or not) and have completed both rounds of the second Competition (without having been eliminated or having retired).



- If, for any reason, one or more of these 25 best placed Athletes are unable to start, they may be replaced by the next best Athlete(s) from the reserve list of five Athletes (Art. 313.3 Rules for Jumping Championships and Games, 27th Edition, 2022).
- Round B of this third Competition is open to the 12 best placed Athletes and Horses according to the cumulative penalties over the first and second Competitions and Round A of the third competition. In case of Athletes tied on cumulative penalties for 12th place following Round A, the result in Round A will be the deciding factor. In case of further equality of penalties, the time of Round A will be used to break the tie.

### Requirements

The third Competition is conducted under Table A not against the clock over two different successive courses rounds at a speed of 400 m per minute, without a jump off in the event of equality of Penalties for first place in the classification of the Competition; in the event of equality of Penalties for first place in the overall classification for the Championship, there will be one jump-off against the clock (see Art. 314.2). At the discretion of the Technical Delegate, depending on the size of the arena, the speed may be reduced to 375 m per minute.

**Round A:** Eleven to thirteen obstacles, including one double and one triple or three doubles. Height 1.65m max with a spread proportion not exceeding 2.00m (2.20m for the triple bar.) A maximum of two spread obstacles with a width of 1m or less may be used. At least two vertical obstacles, which must be a minimum of 1.60m in height. Sloping walls do not count as compulsory vertical obstacles. At least six other obstacles of at least 1.40 m in height. Water jump, if used (see Art. 308.3): four meters 4.00 m including the take-off element.

**Length of course:** 450 m Minimum, 600 m Maximum.

**Round B:** A different course from round A comprising a maximum of Twelve obstacles, including two combinations (one double and one treble or two doubles). Height 1.65m max with a spread proportion not exceeding 2.00 m (2.20 m for the triple bar.) A maximum of two spread obstacles with a width of 1.00 m or less may be used. At least two vertical obstacles, which must be a minimum of 1.60m in height. Sloping walls do not count as compulsory vertical obstacles. A water Jump may not be included, but an obstacle with water beneath, in front or behind (a so called "Liverpool") may be included in the course.

**Length of course:** 400 m minimum, 550 m maximum.

**Speed:** 400 meters/minute.

**Course Inspection:** Athletes will be invited to inspect the course for Round B at the conclusion of Round A.



### **Starting Order**

According to Art 313.5 Rules for Jumping Championships and Games, 27th Edition, 2022)  
Scoring Method This third Competition is conducted under Table A not against the clock (Art. 313.1 Rules for Jumping Championships and Games, 27th Edition, 2022) over two different successive rounds without a jump-off in the event of equality of penalties for first place in the competition;

### **Championship Individual Placing:**

Athletes receive their overall placing by adding the penalties incurred in the first, second and third Competitions. The Athlete with the lowest number of penalties will be declared FEI World Champion.

In the event of equality of penalties for first place in the overall classification for the Championship, there will be a jump off against the clock over at least six obstacles, which may be increased in height and/or spread. Athletes with equality of penalties for any other placing will be placed according to their combined times on Rounds A and Round B of the third Competition, the Athlete with the faster time being placed ahead of the Athlete with the slower time.

If after the jump-off there are Athletes with equality of Penalties and time, the Athletes concerned will be placed equal.

**g. Age of Horses:** must be at least 7 years old (Art. 717).

## APPENDIX 1 – FEI CODE OF CONDUCT

Chefs d'Equipe are required to submit the signed copies of the Code of Conduct to the National Federations Desk upon arrival.

### THE FEI CODE OF CONDUCT for the Welfare of the Horse

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the Horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition Horses, welfare must take precedence over all other demands. This includes good Horse management, training methods, farriery and tack, and transportation.
2. Horse and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and misuse of aids.
3. Events must not prejudice Horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the Horse for onward travel after the event.
4. Every effort must be made to ensure that Horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their area of expertise.

I hereby state unequivocally that in consideration for authorization to compete in the ECCO FEI World Championships Herning – Denmark 2022 (Herning2022): I AGREE that my participation is voluntary and that I am fully aware and acknowledge that horse sports including Herning2022 involve inherent dangerous risks of accident, loss, and serious bodily injury including but not limited to broken bones, head injuries, trauma, pain, suffering, social and economic loss, and/ or even death (“Harm”). I represent that I have the requisite training, coaching and abilities to safely compete at Herning2022 and that I am in good health and proper physical condition for participation at Herning2022. I further agree and warrant that if, at any time, I believe the conditions to be unsafe, I will immediately discontinue further participation and report such unsafe conditions to officials. I AGREE to release the Fédération Equestre Internationale (“FEI”), the Herning2022 Organising Committee, as well as all of their officials, officers, directors, doctors, veterinarians, employees, agents, personnel, volunteers and affiliated organisations, sponsors, advertisers, owners and lessors of any premises as well as any and all event participants (“Released Parties”) from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Released Parties. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the conditions of the grounds on which Herning2022 take place and the negligence of the Released Parties. There may be OTHER RISKS either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR ANY LOSSES, COSTS, AND DAMAGES I incur as a result of such risks. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Released Parties and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at Herning2022. I have read the FEI Rules about protective equipment and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Released Parties strongly encourage me to do so while WARNING that no protective equipment can guard against all injuries or Harm. I AGREE that if I am injured at Herning2022, the medical personnel treating my injuries may provide information on my injury and treatment to the Herning 2022 OC on the official accident/injury report form.

BY SIGNING BELOW, I CONFIRM THAT I HAVE READ THIS AGREEMENT, THAT I FULLY UNDERSTAND ITS TERMS AND CONTENTS, INCLUDING THE FACT THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I ALSO ACKNOWLEDGE THAT I AM SIGNING THIS DOCUMENT OF MY OWN FREE WILL AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT. I ALSO AGREE TO BE BOUND BY ALL FEI AND OC APPLICABLE RULES, INCLUDING BUT NOT LIMITED TO, THE EQUINE ANTI-DOPING



AND CONTROLLED MEDICATION REGULATIONS AND ANY AND ALL RULES APPLICABLE TO HERNING2022.

## APPENDIX 4 – STABLES SAFETY AND SECURITY

### CLOSURE OF THE “ECCO FEI World Championships Herning – Denmark 2022” STABLES AT NIGHT

FEI Clean Sport measures require stricter control of the stables to maintain integrity and to protect the horses and persons responsible.

The stables at competition venues will be closed each night during the Championship period. Generally times of closure will be from 23:00 to 06:00 but this could vary depending on discipline and competition times and will be confirmed nearer the time of the Champions. In compliance with the FEI Veterinary Regulations, accredited individuals will only be allowed to undertake FEI Steward supervised visits to their horses during that time. **Please take note that grooms will therefore not be permitted to sleep in the stable blocks overnight.**

A series of measures will be in place to contribute towards ensuring horse health, safety and security is maintained during this period of closure:

- Grooms are all being accommodated a very short distance from the stables.
- There are Veterinary Clinics with experienced night staff on venue and additional expert Veterinary staff accommodated nearby who will be on call 24 hours per day/7 days per week.
- Experienced teams of FEI Stewards will patrol the stable blocks during the closed hours.
- Full details of all stable visits will be logged and once identified; visitors will be escorted by a FEI Steward during the entire period that they are present in the stables.
- If any concerns arise, the relevant grooms and team vets will be immediately alerted.
- CCTV cameras will be in operation in stable blocks throughout the night monitored by FEI stewards and the Equestrian Community Integrity Unit (ECIU).
- Security personnel will control the venue area and ECIU personnel will be on site throughout the Games period for additional support and to ensure the integrity of all FEI Competitions.
- Horses in need of veterinary supervision will be moved to the on-venue Veterinary Clinic, and informed to the groom, team vet and relevant NF personnel immediately after.
- Appropriate fire precautions will be in place and evacuation procedures established and communicated to all concerned.
